



Who We Are

President's Report 2012

This has been another successful year for the Foundation. The matching program was extremely successful again with \$30,000 from our donor easily reached by the donations received from individual donors to the foundation. This year we had the additional incentive for donors that anyone who donated \$1000 or more between Nov. 1 and Dec. 31 would be our guests at the gala and receive special thanks. This worked quite well and many donors did attend the Gala. City and Regional District support has remained



strong and with more funds from NDI we are growing by leaps and bounds, with our endowment funds in excess of \$1,350,000.

This year we were able to grant in excess of \$40,000 and the details of the grants are listed elsewhere in this report. Needless to say, we are very happy to be able to make such a contribution to the community and expect even larger grants in the future as the endowment fund grows. Our gala took place in March and was extremely well attended. Doug Service did an admirable job as MC and we were pleased many donors were able to attend. As well the auction was extremely successful due to the efforts of Lorna Townsend and her committee of Shirley Keen, Doug Service, Sandy Norman and Shauna Vaupel and our coordinator Nancy Lilienweiss.

As usual there were some changes to the directors at the annual meeting. As Lorna Townsend has completed six years as director she was not eligible to continue and Doug Service had completed his term as director. Their efforts have been of great assistance to the Foundation and they will be missed. However they have been replaced by two new directors Ray Levac and Heather Wuensche who will contribute to the ongoing success of the Foundation. Our long time coordinator Nancy Lilienweiss has accepted another position that does not allow her to continue her duties with the Foundation. Her helpful nature and knowledge of Foundation background and contacts will be a major loss and will require increased work from the directors for a period. However we are pleased that Cathy Briggs is joining the Foundation as coordinator and confident that she will enable the Foundation to continue on the successful path that has been established.

The community support of the Foundation has been tremendous and it is what makes the work of the directors worthwhile. 
Double Your Gift


Double your gift, and double your impact to make a real difference in your community both today and in the future. The last day to give a gift that will be matched is December 15.

Grants 2012

The Quesnel Community Foundation continues to be a major supporter of the area's non-profit sector. On March 24, \$34,450 in grants was awarded to these organizations:

\$700 to Big Brothers Big Sisters for funding for a binding machine and laminator. This grant has been made possible through the generous support of the Warden Family Fund.

\$2,000 to the Bouchie Lake Recreation Commission for signage for the Claymine Trails. This grant has been made possible through the generous support of the CRD Area B Fund.

\$2,000 to Correlieu Secondary School to purchase a defibrillator. This grant has been made possible through the generous support of the Glenn & Loretta Barr Fund.
