




PRESIDENT'S MESSAGE



It is both an honour and privilege to bring you this Community Update as President of the Quesnel Community Foundation. As a member of the steering committee for this great organization back in 2000-2001 I am very excited to be part of the Board and volunteers of OUR Foundation. We continue to impact our community in so many positive ways. Our fundraising in 2016 including all our sponsors and in-kind donations exceeded \$175,000 and we now have over \$2.4 million in our Endowment Funds! **Thankyou Quesnel!**

None of this would be possible without the continued efforts of so many wonderful and dedicated volunteers. First and foremost, I'd like to thank our Board of Directors for contributing so much of their valuable time to support the growth of our foundation. Sadly we say goodbye to three Directors who retired from the Board in 2017. Margot Gagne, Heather Wuensche and Bob Lebeck all worked tirelessly in their respective capacities to help build a better future for Quesnel. As our past president, thank you Bob for your leadership and the many hours you dedicated personally reaching out on behalf of the Foundation - big shoes to fill! We welcome new Directors Gayle Campbell, Adrian Monych and Doug Service who have joined the TEAM, and were quick to assume leadership roles. Also joining us is our new Coordinator Anna Rankin. We wish Simon Turner the very best as he leaves the position to explore retirement.

The Quesnel Community Foundation exists to meet the needs of our community through the growth and management of permanent endowment funds. We operate under the premise that all donations received will be used to generate investment income which funds our grants. The capital created by those donations is never spent. As our endowment grows, our ability to fund grants also grows. In 2017 we awarded over \$67,000 in grants to eighteen projects! In addition \$7000 was given in bursaries and scholarships and \$3500 in Agency Funds to Island Mountain Arts and Friends of Quesnel and District Museum. The value of the grants disbursed continues to grow annually.



Our 2018 Grant cycle opens on November 1. If your organization is looking for funds to complete a worthy project, please see our Web Site for details. **Project Proposals** are due **5 p.m. Friday, January 12, 2018**. We look forward to seeing and hearing about future Community Projects.

Lastly, our fundraising efforts have been boosted in recent years by the extreme generosity of an anonymous donor. We are thrilled to announce that once again a donor will provide matching funds to the Foundation for donations received between November 1 and December 10, 2017, up to a maximum of \$50,000. 




