“On behalf of the Board of Directors of the Quesnel Community Foundation, I am pleased to provide our community update for 2022.

As per our audited financial statements, the fundraising for 2021, including in-kind support and sponsorship, was \$187,200.00. The value of the Endowment Fund as of December 31, 2021, was \$4,113,840.00.

In 2022 we awarded \$108,550.00 to community groups in the form of grants, and \$18,250.00 in bursaries and scholarships to local students. None of this would be possible without the generous support and donations from the people of Quesnel and area.

I would also like to acknowledge the hardworking volunteer members of the Board of Directors for their support and commitment to the smooth running of the Foundation. Over the past year, we said goodbye to two members of the Board, Adrian Monych and Ed Coleman. We would like to thank them for their significant contributions to the success of the Foundation. We are happy to welcome Candace Gibbs and Vanessa Salmons to the Board of Directors.

On October 15, 2022, our annual Community Fall Challenge Campaign will begin. Once again our generous anonymous donor will be matching funds, up to \$50,000, to our endowment fund. With these matching funds, it is a great time to donate to the Quesnel Community Foundation.

In closing, I would like to thank the people of Quesnel and area for their continued support of the Foundation, and the many organizations and students that we are able to help with funding.
