PRESIDENT'S MESSAGE

On behalf of the Board of Directors of the Quesnel Community Foundation, I am pleased to provide our community update for 2025.



Total fundraising to September 30th 2025, including in-kind support and sponsorship, was \$274,417.73. As of December 31, 2024, the QCF Endowment Fund was \$5,723,057, thanks to the generous support and donations from the people of Quesnel. In 2024, grants and community programs in the amount of \$209,000 were distributed. We also awarded \$31,250 in bursaries and scholarships to local students.

Over the past year, we said goodbye to our long-serving Treasurer, Laurie Rice. We thank Laurie for her significant contributions to the success of the QCF over the past six years. We are pleased to welcome Ryan Adams to the Board of Directors and as our new Treasurer.

Our annual Community Fall Challenge Donation Campaign will run this year from October 15 to December 15, 2025. Again, our generous anonymous donor will match funding up to \$50,000. It is a great time to donate to the Quesnel Community Foundation.

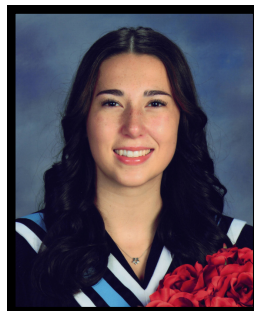
The Lhtako Quesnel 2024 BC Winter Games were held in partnership with the Lhtako Dene First Nation the City of Quesnel, Cariboo Regional District and SD#28. Taking place on the Traditional Territory of the Lhtako Dene First Nation, the event brought 1,800 athletes, coaches and officials from across the province to compete in 16 different sports. Over 1000 community volunteers provided sport, meal, transportation and housing support.

The event was an incredible success and served as a key development opportunity for BC's young athletes while at the same time focussing on the diverse and rich culture of the Lhtako Dene First Nation's Traditional Territory.

In the winter of 2025 the Organizing Committee made two significant gifts to the Quesnel Community Foundation that will bear impact in the years to come.

The first was a **\$100,000 endowment** to support not-for-profit organizations whose mission is to further sport and recreation within the local community. This year's recipient is the Troll Freestyle Club, which used their grant to purchase ski equipment to improve access for those who may not have the financial means to otherwise participate.

The second gift exceeded **\$50,000** and this was used to create a bursary fund to award two bursaries each year to qualified Gr. 12 students pursuing their sport at the post-secondary level or a sports-related field of study such as kinesiology, rehabilitative medicine, officiating, coaching, etc.
